

Dear Friends,

At the outset of this newsletter, I wanted to make sure you are all aware that there is a **very important community meeting regarding the Edison Project at 776 Summer St this Wednesday evening, September 19th from 6PM-8PM at the Tynan School (650 East 4th St) in South Boston.** If you are able to do so, I respectfully ask that you join me in sharing your concerns regarding this project. My staff and I continue to work hard on behalf of each of the neighborhoods in District 2. With summer winding down and fall fast-approaching, here's an update as to what we had been working on earlier in the season:

### **Budget**

Due to the relentless advocacy of community leaders like Marleen Neinhus and the Friends of the South End Library, we were able to work closely with Mayor Walsh and his budget staff to help secure \$400,000 for the South End Branch of the Boston Public Library. Thank you again to Mayor Marty Walsh, Boston Public Library President David Leonard, my colleagues on the Boston City Council, President Andrea J. Campbell, fellow District Councilors City Councilor Kim Janey, Boston City Councilor Frank Baker. Thank you also to the At-Large Councilors - Councilor Michelle Wu, Councilor Michael Flaherty, Councilor Annissa Essaibi George, Councilor Ayanna Pressley & Friends of the South End Library for your advocacy to secure funding & investment in the future of this exceptional library and the residents of the South End. 

## **Support for Working Families**



I was proud to march with Massachusetts Nurses Association (MNA) President Donna Kelly-Williams and alongside working people recently in solidarity with 1,200 members of USW Local 12003 and 12012 as we continue to stand for social and economic justice. Working men and women of this city and state deserve to be treated with dignity and respect.

With the recent Supreme Court decision in Janus v. AFSCME, it should be clear to all that, now more than ever, we must continue to support the labor movement and stand with working families. National Grid had a 24% increase

in profits this year. It is unconscionable for them to lock out hard-working utility workers and suspend their healthcare benefits.

We once again called for fair wages, affordable healthcare and decent pensions for all of their workers. It is essential to public safety that we ensure a highly-skilled, properly trained and professional workforce deal with these potentially dangerous situations. This is not a job you can contract out to the lowest bidder. It requires professionals like Boston Gas Local 12003 and 12012.







In June, I sent a letter on behalf of my fellow City Councilors urging National Grid to approach these negotiations in good faith and the spirit of fairness. Together we will continue to fight for fair and living wages, affordable healthcare, and decent pensions for all workers until we end this lockout.

My father, former Boston Mayor Ray Flynn, recently wrote about the outpouring of support for these workers in the Boston Herald. He called attention to the values of the labor movement and the enormous contributions its made to the middle class and workers in Boston, across the United States and the world. The determination of these working families inspires me just as

the striking shipyard workers Mayor Flynn & I witnessed under oppression in Gdansk, Poland. <u>You can read more about this rally for the locked out workers</u> in the Boston Herald here.

Councilor Matt O'Malley & I offered a resolution in August support supporting these workers locked out by National Grid. In my speech, I called attention to the significant public safety concerns and how critical it is to put them back to work on our gas lines. You can view my remarks here:




